The meeting agreed that the issue of Movement of Business Persons falls under its competence and guided as follows:

Movement of Business Persons should not be incorporated in the TFTA; and

the TTC-MBP should develop content and define the appropriate legal instrument to be used.

The meeting directed that work on Movement of Business Persons be fast tracked and future reports should be submitted to this Ministerial Committee.

#### **Business needs**

1. Common business visa free entry document

- a) Without fees and additional documentation
- b) Similar to APEC Business Travel Card (ABTC)
- 2. Eventually, business passport for region
- 3. Elimination of visa fees in the region

To reduce trade transaction costs associated with business travel in the region:

- time costs in completing visa applications
- time costs in completing immigration processing
- cost of visa application fees

# Options for possible scope of agreement

- a. Business mobility facilitation
  - See APEC Business Travel Card
  - Other APEC initiatives / SAFTA provisions
- b. Market access / national treatment
  - E.g. GATS
  - Not limited to service suppliers
- c. Immigration and labour facilitation
  - Simplification / standardization of documentation and procedures
  - Cooperation between authorities
  - Exchange of confidential information


