The Republic of Zimbabwe herewith submits its List of Commitments covering construction and energy-related services, in the context of the SADC Protocol on Trade in Services. This List covers offer in construction and related engineering services and energy-related services.

In line with Negotiating & Scheduling Guidelines for the 1st Round of SADC Trade in Services Negotiations Adopted by TNF Services on 11 November 2009 and Approved by CMT on 12 February 2011 paragraph 28¹; all new commitments being undertaken in this offer uses the latest United Nations Classification (CPC) Ver.2.1. The Central Product Classification (CPC) Ver.2.1 was released on 11 August 2015. As of this date, all previous draft versions become obsolete.
